1. Mi 50 aia tam punkhawm khap tlat a ni a, chhungkhat laina pawh a tlem thei ang ber kal thin nise, association/pawl aiawh mi 2 (pahnih) aia tam kal loh tur a ni. Kalkhawm thei zat leh kalkhawm turte hi a veng neitu YMA leh VLTF ten tlangau hmanga puanzar thin ni se.
2. Social distancing a awm theih nan kohhran/community hall emaw vengchhung-a hall remchangah invuina hun hman tur a ni. Hemi atan hian mitthi lawina kohhran leh a veng neitu YMA leh VLTF ten ruahmanna an siam ang.
3. Chhياتni thatni-a kal zawng zawngte hmingpum, address leh contact number chhinchhiah tur a ni a, a remchan dan angin YMA leh VLTF ten ruahmanna an siam ang.
