4. Santizer chhawp vek tur ani.
5. Dawr chhungah dawr nghtute nilo chu inleng emaw dawrtute emaw te chu thut khawmuan phal a nilo.
6. Dawr chhung leh pawnah dawrtute inhlal thei ang bera an awm theih nan dawr neituten ruahmanna an siam ang.
7. Online shopping leh delivery te midang nena intawk lo in kalpui phal ani.

VI. Duty chungchang:

1. CAB Implementation Team leh VLTF-te uluk takin an duty thin anga, hmun pawimawh laiah tul lova mipui chhuah vahna a tlem theih nan leh khuahkhirh anih theih nan an duty anga, a khat tawkin veng chhungah patrolling an nei thinang.
2. A tul dan ang zelin Police duty dah turin Superintendent of Police, Khawzawl District in ruahmanna a siam ang a. DC in sawrkar hnathawk Executive Duty dah turin ruahmanna a siam bawk ang. Police leh Executive Duty te hi uluk takin an duty thinang.
