Mizoram Sawrkar, Disaster Management & Rehabilitation Department Order No.B.11015/5/2020-DMR dated 31.01.2022 in hmun dang atanga vawk leh vawksa atanga siam lakluh chungchanga inkhuahkhirhna a tarlan angin, African Swine Fever (ASF) vanga Khawzawl District mipuiten harsatna kan tawh loh nan thupek chhuah tulin ka hria a.

2. Vawk lalut turten Veterinary Surveillance Office/Check Post paltlang chauhin an lalut tur a ni. Vawk lalut tur chuan Veterinary Officer-in a enfiash theih turin Vaccination Certificate (Classical Swine Fever) an nei tur a ni.
3. Vawk lalut tur reng rengin dilna form hi District AH & Veterinary Office, Khawzawl-ah Rs. 10/- in lei tur a ni.
4. Khawzawl District chungah bikah khaw pakhat atanga khaw danga vawk lakluh chu, VFA emaw CAHW leh VC te hriatpuina in phal a ni .
5. Khawzawl District chungah, vawk hrisel tha ni a hriatte chu Animal Husbandry & Veterinary Department leh Village Council te hriatpuina chauhin talh theih a ni ang. Vawk talh dan tur ruahmanna kimchang District Animal Husbandry & Veterinary Officer in a siam chu vawk talh tur ten zawm vek tur a ni.
6. ASF rinhlelh vawk damlo/thi a awm chuan rang taka report tur a ni a. Vawk thi a awm chuan tha takin (6ft a thukah) chinai nen phum tur a ni.

He thupek zawm lote chu thubuai siam sak an ni ang a, **IPC Sec. 188** hmangin hrem theih an ni ang.

He thupek hian he Office Order number ngai dated 27.01.2022 chu a luahlan ang a, tihchhuah a nih atanga thla 2 (hnih) chhung a huam ang.

He thupek hi District Magistrate Seal a nemnghetin vawiin **Ni 16 March, 2022** hian hming ka ziah hnan e.
