2. Zonal Officers are required to promptly apprise QRT Nodal Officer/ Conveners if any search & rescue operation is required.
3. As disaster mitigation and rehabilitation is a team effort and entails involvement of all stakeholders, Zonal Officers shall endeavour to harmonize their activities/ actions with their respective Village Level Disaster Management Committee.


