

**2. MLALADS Fund hmanga hnathawh theihthe:**

- 1) Zirna lam kaihnawih In sakna atan. (Construction of Educational buildings).
- 2) Khawtlang tlan tur – tuikhur, tui verh (tui pump) siamna atan.
- 3) Khaw panna kawng emaw khawchhung kawng siamna/laihna emaw atan.
- 4) Tar leh pianphung a rualbanlote a huhoa an chenna tur (Tar enkawlina In, etc) sakna atan.
- 5) Sangha dil siam leh cheithatna atan.

- 13) Mihring kalna bik (footpath) siamna atan. (Mihring zawh tur lei pawh a huam thei ang).
- 14) Vantlang zawh tur step siamna atan.
- 15) Vantlang hman tur Bus waiting sheds siamna atan.
- 16) Ran enkawlina hmun (Veterinary aid centre) siamna/enkawlina atan.
- 17) Nunna atana hlauhawm thei – leimin, leitawlh ang chi a lo thlena chhawmdawlina atan.
- 18) Community Hall sakna atan.
- 19) Infiamna, khelmual, etc (sports infrastructure) siamna atan.
- 20) Chhenna in sak leh siam thatna atan.(Tul bik thilah chiah)
- 21) Vantlang hamthatna tura sawrkar hriatpui hna thawhnaa mimal mahni ram petu / hmantirtu te ram buaipuina senso atan.
