NOTE:

- 1) Applicants of Gurkha origin should bring certificate from the DM/ Deputy Commissioner/ District Collector of their Districts to prove that they are Indian Nationals.
- 2) Applicants from Tripura and the Districts of Karimganj, Hailakandi and Cachar of Assam should enclose a relevant extract of E/Roll countersigned by concerned E.R.O or attested copy to E.P.I Card(Voter's ID card) or residential / birth certificate from the concerned Deputy Commissioner.
- 3) 1(one) passport size photograph each of applicant and sponsor should be enclosed.
- 4) The applicant is required to pay the fee of Rs.20,000/- for a new 2 years ILP for companies/firms, traders/businessmen and canteen contractors. Rs. 2,000/- for new ILP of 6 months for laborers and Govt. employees on casual, contractual, muster roll with their family member where e-District ILP System is in operation and Rs. 200/- where e-District System is not in operation.
- 5) Holder of ILP who fails to submit application for renewal or extension before expiry of the validity shall be fined @ Rs. 10/- per day of overstayal in Mizoram till date or receipt of application for extension, renewal or fresh ILP.
