REPORT ON INSPECTION OF PUBLIC ROADS IN ZAINGEN, ZUCHHIP, DINTHAR AND ELECTRIC VENG

In pursuance of instruction of Deputy Commissioner, Khawzawl District and in order to safeguard existing roads and prevent activities causing encroachment of and damage to public roads, inspection of main road in some localities of Khawzawl was carried out by Khawzawl Road Protection Squad in the morning of 15th July, 2021.

The inspection was carried out on foot from Taidawnkawn, Khawzawl Zaingen at 6:30 am. It covered the main road connecting Zaingen, Zuchhip, Dinthar and Vengthar localities including some parts of National Highway No. 6 in Vengthar. All members of Road Protection Squad were present during the inspection, and were assisted by members of Village Councils and Young Mizo Associations of concerned localities.

During the inspection, several cases of encroachments into public road reserve areas and actions causing obstruction/nuisance to public roads were found. The offenders were notified on the spot to remove such encroachments/nuisances within time limits specified based on the kinds of offences. They are also issued Conditional Order under Section 133 of CrPC, 1973 (2 of 1974) with copy given to Village Council President concerned.

Based on the inspection, following are observations and suggestions of the undersigned:

- i) Roadside parking of vehicles is still commonly practiced even though there is a standing order by District Magistrate requiring those owning vehicles to have garages (Order No.J.12017/1/2021-DC(KZL) dt. 16.06.2021). It may be a prudent step to request Superintendent of Police, Khawzawl District for strict enforcement of the aforementioned order.
- ii) Inspection of roads may be conducted at least once a month (or more frequently) with one or two localities covered in each inspection. This way, each locality may be covered more thoroughly by including second lane and below (if any) in the inspections.
