**PROHIBITORY ORDER U/S 144 Cr.PC, 1973**

Hetiang hi kan dinhmun a nih avangin mihring nunna atana hlauhawm hripui COVID-19 inkaichhawn theihna zing a mi - mipui punkhawm/pawnlama khawsak ho dul dul/inhnaihchilh taka chenho hi kan pumpelth hram hram a tul hle ni a hriatna a awm a ni. Hei hi thlirin he natna laka Khawzawl District mipuite kan lo him ngei theihna turin thupek thar tihchhuah ngaiin ka hria a.

- 9) **COVID-19 chungchangah thu diklo/belhchian dawlo thehdarh phal a ni lo.**
