Chuvangin, Regulation 11(1) of 'The Mizoram Epidemic Diseases (COVID-19) Regulations, 2020' tlawhchhanin, ni **28.05.2021 atanga thu leh awm hma** chu a hnuai veng/hmun tarlan hi **Containment Zone**-ah puan a ni.

“Kawlkulh South Branch YMA area huam chung, Kawlkulh IB pan chhohna peng bul chiah, Pu Rosiama Pautu in atanga chhim lam zawng, High School Veng telin, Saihum Veng (Khawzawl Road) Pu Lalparliana in thlengin.”
