1. Sports inelna (tournament) bakah sports practice chu hemi hun chung hian phal loh a ni.
2. Khawzawl District-a dawr leh bazar, restaurant leh thingpui dawr bakah Courier Service, e-Commerce leh home delivery te inhawn hun chu a ngai anga kalpui chhunzawm tur a ni.
3. Mizoram chhugn hmundang, a bikin Aizawl atanga rawn haw/zin te chungchang sawiho a ni a. Case rinhlelhawm bikah chuan Village Level Task Force (VLTF) te leh anmahni bialtu Zonal Officer/ Medical Team ten a tul ang zela hmalak ho thin nise tih a ni.

Mizoram Sawrkar, Disaster Management & Rehabilitation Department order **No.B.13021/101/2020-DMR/Vol-V** dt. 16.07.2021 Clause C.2 in a tarlan angin phalna nei a pawn chhuak/zin te leh, inkaihhrainain a phalsak sa te veivah nan commercial passenger vehicle (taxi, maxi cab etc.) te chu hiring system a hman phal a ni.
