- 2) Vawk thi reng reng tha taka phum vek tur a ni a, khamah emaw kawrah emaw paih mai loh tur a ni.
- 3) Vawk talh tur te'n Vawk hrisel tha chauh an talhin an zuar tur a ni.
- 4) Vawk vulhtu/neitute'n Vawk damlo an hralh tur a ni lo.
