2. DEO/DMEO ten Form 21 hmanga dilna awmdan a zirin Make-shift drop box leh Voting Compartment leh Arrow cross marks te an arrange ang.
3. DEO/DMEO-ten an dilna chu lo chingfelin an vote neihna theuhte Ballot Paper Book No.1 (Both General & Reserve) a mi a Serial No.1 atanga pawthlain chutiang voter awm zat te chu an pe ang. Eg. 5 an awm chuan Sl.No.1-5.
4. Voting compartment leh arrow cross marks te buatsaih sak an nih a, an duh naah ngei an vote hnuah an vote chu a thlehdan tur ang taka thlepin envelope-ah an khung thlap ang a, an seal thlap ang. Envelope kawmah an vote neihna Returning Officer (RO) address-in Make-shift Drop Box-ah an thlak ang.
5. DEO/DMEO ten Drop Box chu hawngin Last Day of Training-ah RO/PRO te Election materials hawn turah a in seal that leh that lohte an check hnuah an telh ang.
6. Chung Sealed Envelope te chu Inthlan niah a remchang hmasa berah RO in Candidates/Polling Agents-te Envelope chu a in seal tha a ni tih a entir hnuah a hawng anga, ballot paper a Election Duty Voter in a vote-na tilang miah lovin Ballot Box-ah Polling Agents/Candidate-te hmuh lai ngeiin a thlak ang.

7. Poll Day hma a Ballot Paper lo pawhthlak a nih tak avangin Presiding Officer in Electoral Roll Mark copy-ah mark fel vekin Ballot Paper Account (Form 26) tibuai lo turin a tifel ang.
