Khawzawl District-chhungah pawh **Covid-19 No Tolerance Drive** hi November thlatawp thleng kalpui chhonzawm tur a ni. Hemi hun chhunga inkaihhraina chu a hnuaia mi ang hi a ni ang:

1. Khawzawl District chu Zone 13 ah then niin, Zone tinah Sawrkar hnathawk, police leh VLTF te awmna **Covid-19 Executive Duty Team** din a ni a. Executive Duty Team te chu inkaihhraina hman lai anga kal chhonzawm tur a ni ang.
2. No Tolerance Drive chhung hian The Mizoram (Containment and Prevention of the spread of Covid-19) Act, 2020 leh Covid-19 kaihhnawiha thupek hrang hrang bawhchhiate chu dan hmanga hrem theitute kaltlangin inngaihnhathiamna awm lovin hmun leh hmunah pawisa chawitir/hrem zel an ni ang.
3. Mizoram pawn atanga rawn lutte chu Health & Family Welfare Department in inkaihhraina a siam anga Quarantine chhonzawm an ni ang.
4. Kan lo him tlan zawk theih nan Khawzawl Darngawn Veng-a Mualvawm Park leh a chhehvel chu tlai dar 5:00 atanga zing dar 4:30 inkar chhung tlawh khap a ni.
5. Mizoram sawrkarin November 7, 2020-a No Tolerance Drive Order a tihchhuah chu Khawzawl District-ah pawh hman tur a ni a. A langsar zualte chu a hnuaiah tarlan a ni:
 - i) District Magistrate, Khawzawl in order No.J.12017/1/2019-DC(KZL) dr. 01.10.2020 kaltlanga a tihchhuah tawh angin Khawzawl-ah phaln nei lova vantlang hmuna mi **5 (panga)** aia tam awmkhawm khap a ni a. Tin, zan dar **8:00** leh zing dar **4:30** inkarah phalna neite tih loh chu pawnchhuah khap tlat a ni.
 - ii) Thu leh awm hma chu school, college, educational/coaching institute te chu khar chhonzawm a ni ang a, online hmangin zirtirna an kalpui thei ang. Zirtirtute rawn tura school-a kal pawh khap rih a ni ang.
 - iii) Sakhaw biakna hmunah te chuan mipui punkhawmna huaihawt phal a ni lo. Biak In a zing tawngtai erawh chu mi 25 aia tam lo tan neih phal a ni.

- iv) Mipuiten a hmuna en theih tur games & sports tournament huaihawt phal a ni lo. Entu mipui punkhawmna tel lo games & sports practice erawh chu Indoor-ah mi 10 aia tam lo leh pawnah mi 25 aia tam punkhawm khap chhungin neih phal a ni.
- v) Cinema hall, auditorium, community hall, picnic spot, swimming pool leh hetiang intawllenna hmunte chu khar chhonzawm tur a ni.
- vi) Mitthi vuina leh inneihna (man hlan, inneih inkhawm leh reception) ah te chuan mi 35 (sawmthum panga) aia tam punkhawm khap a ni a. Heng hmuna telte chhinchhiahna kimchang (hming, address, phone number leh kal hunt e) ziahna bu/register emaw **Sulnu** mobile application hmanga chhinchhiahna a huaihawttu ten an vawng tur a ni.
- vii) Dawr zawng zawng chu (damdawi dawr tiam lovin) tlai dar **5:00** hma-in khar vek tur a ni.
