Mizoram Sawrkar, Disaster Management & Rehabilitation Department order **No.B.13021/101/2020-DMR/Vol-IV** dated 05.06.2021 kaltlangin Mizoram pumah Lockdown pawhsei a ni a. He order bawhzuina atan leh, Covid-19 hrileng darh zel laka kan him theih nan, **The Disaster Management Act, 2005 Section 30(2)(xviii)** leh **Section 34(m)** in District Disaster Management Authority hnena thuneihna a pek angin a hnuiaia Lockdown inkaihhruaina tarlante hi Khawzawl District-ah ni 14.06.2021 zing dar 4:00 thleng mipuite zawm turin chhuah a ni e.

A. KHAWZAWL DISTRICT PUMA HMAN TUR

1. Mizorama lo lutte quarantine leh test chungchang:

- i) Mizoram pawn atanga lo lut, entry point-a Rapid Antigen Test (RAgT) negative certificate nei, Home Quarantine phalsak tawhte chu midang nen in contact lovin ni 10 chhung mahni inah (Home Quarantine) an inkhunghrang ang.
- ii) Home Quarantine hi mCovid-19 application/website kaltlangin, a hnuia link tarlanah hian Mizoram a rawn luh hma ngeiin dil thin tur a ni. (<https://mcovid19.mizoram.gov.in/pages/qf-application>)
- iii) Home Quarantine phalna nei lo te chu an awmna veng/khua Community Quarantine Facility (CQF) ah ni 10 chhung an inkhunghrang ang a. Chhan engemaw bik vanga CQF-a awm remchang lote chauh Government Quarantine Facility (GQF)-ah khunghran an ni ang.
- iv) Home Quarantine/CQF/GQF a awmte hi ni 10 hnuah RT-PCR/TrueNat test an nei ang a, negative result an neih chuan inkhunghran chhunzawm a ngai tawh lo ang. Positive result neite chu sawrkar dan dinglai angin Covid Care Centre/Community Covid Care Centre ah enkawl an ni ang.

2. Bungraw chawkluh leh state chhunga phurh chungchang:

- i) Mizoram pawn atanga bungraw lak luh phurtute (driver leh handyman) entry point-a screening paltlangte chuan an kalphung pangngai angin khaw dâiah anmahnii eirawng an inbawl chawp ang a, khaw chhungah midang nen inchiahpiah lovin an bungrua an unload zawh veleh an let leh nghal ang. An bungrua unload chhung hian midang te atanga feet ruk (6) tala hla-ah an awm tur a ni.
- ii) Heng motor-ah te hian driver leh handyman bak midang (passenger) an chuang tur a ni lo.
- iii) State pawn atanga bungraw lak luh phurtute (driver leh handyman) te chu backload lak tur zawngin Khawzawl District chhungah an kual emaw, an ding khawmuang tur a ni lo.
- iv) Khawzawl District-a bungraw awmsa emaw siam chhuah/tharte hmundanga thiar/phur tur leh Mizoram hmun dang atanga Khawzawl District-a bungraw phurlut turte chuan an chhuah tanna VLTF hriatpuina lehkha an nei tur a ni.
- v) Public Distribution System (PDS) hnuaia ration dawr/retailer-a pek chhuah tur buhfai, chini leh khawnvartui phur motor te chu FCS&CA Department-in Delivery order/ Despatch Challan a pek chhuah, la nung mek an ken chuan phalna hrarpa ngai lovin Mizoram chhungah bungrua an thiar thei ang. Delivery order/Despatch Challan hi a tul anga Covid-19 Executive Duty/VLTF/Police te enfiah theih turin an keng tur a ni.

3. Zirna In, Sakhaw biakna hmun leh mipui punkhawmna hmun te:

- i) Public park, picnic spot, movie theatre, gym, football/ futsal ground, community hall, restaurant, shopping complex, mall, phalna pek loh dawrte leh intawllenna hmun zawng zawng chu khar chhunzawm tur a ni.
- ii) Zirna in leh Sakhaw biakna hmun te chu khar chhunzawm tur a ni. Board Exam, All India level Exam, recruitment exam adt. te chu phalna hrarpa pek te chauh kalpui theih a ni ang. Hengah te hian exam huaihawttu ten SoP khauh takin an kengkawh tur a ni.
- iii) **College/University zirlai, online exam tura internet connection that zawkna hmun/khua pan ngai te chuan College/University ID card leh Exam Admit Card kengin an kal phal a ni.**
- iv) **College/University a thawk, exam kaihhnawiha duty tura ruatte chu Office ID card leh ruat an nihna order kengin an chenna leh duty na hmun inkara an veivah phal a ni.**
- v) Inneihna leh reception, mitthi vuinaah te mi 30 (sawmthum) aia tam punkhawm phal a ni lo.
- vi) Chhiatni/thatni leh puipunna dang reng rengah ei leh in sem/siam phal a ni lo.
- vii) Mipui punkhawmna heng – birthday leh anniversary lawmna, games & sports, book release, lungphun leh intihhlimna ang chi reng reng te chu he hun chhung hian huaihawt phal a ni lo.

4. Zin veivah chungchang:

- i) Chhiat tawh leh damlohma (medical emergency)-a mahni khua chhuahsana zin a tul chuan mahni awmna veng/khua VLTF te hriatpuina lehkha, kal tanna (origin) leh zinna/kalna tur hmun (destination), zinna chhan, ni leh darkar te chuanna nen zin veivah theih a ni ang. Chhiat tawh leh medical emergency thila Khawzawl District-a lo zin/haw turte pawhin an rawn chhuah tanna veng/khua VLTF/LLTF te hriatpuina lehkha an nei tur a ni.
- ii) **Chhiat tawh leh damlohma ni lo, loh theih loh thil dang a mahni khua chhuahsana zin tulna-ah chuan Deputy Commissioner phalna lak tur a ni.** Mizoram chhung hmun dang atanga Khawzawl District-a lo zin/haw turte chuan an rawn haw tanna Deputy Commissioner/SDO(Civil)/BDO te phalna an nei tur a ni.
- iii) **Phalna hi mCovid-19 application-ah mPass-Inter District (<https://mcovid19.mizoram.gov.in/pages/mpass/inter-district>) hmang pawhin dil theih a ni.**
- iv) Covid-19 hrileng hi Mizoramah pawh khawtuala inkaichhawnna (Community spread/local transmission) a awm tih finfiah a ni tawh a. Chuvangin khualkhua atanga lo zin/haw te pawh inkhung uar a, pawnchhuak tam lo turin hriattir an ni.
- v) Village Level Task Force (VLTF) ten an veng/khua atanga zin chhuak leh, hmundang atanga an veng/khuaa zin/haw te chu fimkhur tak a lo chhinchhiahin a tul angin an vil zui ang. Covid-19 kaihhnawih case rinhlelhawm leh hmanhmawhthlak bikah chuan Medical Team/bialtu Zonal Officer/Police/Deputy Commissioner's office-ah te hriattir vat a, hmalak ho thin tur a ni.
- vi) College/University zirlai, online exam tura internet connection that zawkna hmun/khua pan ngai te chuan College/University ID leh Exam Admit Card an nei ngei tur a ni.
- vii) Phalna nei lo a zin veivakte chu The Mizoram (Containment and Prevention of the spread of Covid-19) Act, 2020 hnuaih hrem an ni ang a, anmahni leh an thlenna/chenpui te nen khunghran an ni ang.

5. A Huhova Pâwn Chhuah

Chhungkua/mimal eizawnna kaihhnawih ni lo a huhova lui kal, ramhnuai picnic, hiking leh adventure sports te khap that a ni.

6. Veng/khaw bil inkhuahkhirhna:

He order in a huam baka veng/khaw bil bik tana inkhuahkhirhna khauh zawk neih tul tihna a awm chuan VLTF ten Deputy Commissioner hnenah ziakin rawtna an thlen ang a. A tul chuan Deputy Commissioner in Containment Zone a puang ang.

VLTF ten anmahni thuin inkhuahkhirhna hranpa/Containment Area/Zone/Total Lockdown an puang tur a ni lo.

7. Hmasawnna hna thawh chungchang:

- i) **Khawzawl District chhunga phalna neia hmasawnna hna kalpui mekte chuan an chhuah tanna VLTF atanga phalna la hmasain, hnathawhna-a hman tur bungrua leh hmanrua thiar/phurh phal a ni.** Amaherawhchu, kawnglaka din khawmuan emaw, khawchhunga veivah chhen phal a ni lo.
- ii) **Insak kalpui mek, slab chhun ngei ngei ngaiah chuan an awmna veng/khua VLTF te phalna la hmasa in vengchhung mi mi 30 (sawmthum) aia tam lo thawh phal a ni.**
- iii) Khawchhung leh khaw kar kawnga Telecom cable te tichhe thei zawngin hna thawk (lung hal, thing kih etc.) phal a ni lo.

- iii) Tul bik thila pawn chhuak tur reng reng chuan (facemask leh hmanraw dang hmangin) hmai an tuam ngei tur a ni a. Vantlang hmuna kal te chu feet 6 tala inhlata awm tur a ni.
- iv) Dawr leh bazar hawn chungchangah vawi khata mipui tam tak pungkhawm tur ven nan VLTF ten ruahmanna an siam ang.
- v) **Public Distribution System (PDS)/Ration buhfai dawrah te chuan e-POS a kutzungtang nem zawha kut tihfaina tur hand sanitizer chhawp ngei ngei tur a ni.**
- vi) District Headquarters pawnah te pawh eizawnna leh hmasawnna hnathawh chungchangah CAB uluk taka zawm chungin kalpui tur a ni.
- vii) He inkhuahkhirhna thupek kalpui chungchangah hian VLTF te chuan an khua/veng chhung theuhvah COVID-19 do nana an hmalaknate an chhunzawm zel ang.
- viii) **MGNREGA, MPLADS, MLALADS hnuiaia hnathawte phal a ni. Hnathawktu ten inhnaih lovin, CAB inkaihhruaina uluk taka zawmin hna an thawk tur a ni ang.**

Amaherawhchu, distributor/wholesaler te kudam/dawra retailer (zuar chhawng tur) ten bungrua la tura an kal khap a ni.
 - iii) Chawhmeh bazar leh dawr te hi tlai dar 6:00 ah chuan khar ngei ngei tur a ni.
- iv) Dawr leh bazar hawn hun chhungah chauh ATM hman phal a ni.**
- v) Bazar leh dawr hawn chungchange Mipui (Bazar turte), dawkai, VLTF leh Covid-19 Executive Duty te mawhpfurhna leh inkaihruaina hman mek, he office lehkha number ngai dated 23.05.2021 a mi chu hman chhunzawm tur a ni.
 - vi) Mahni ina dawr nei te pawh dawr hawn ni lo ah chuan inhralh phal a ni lo.

3. Sawrkar office:

- i) District Headquarters chhunga Sawrkar Office te chu Head of Office ten hna pawimawh bik leh tul zual thawk turin hna thawktu hmingherhin office kal tur an ruat ang. Office kal tura ruatte chuan anmahni ruatna order chu Police/Covid-19 Executive Duty/VLTF te enfiah theih turin an keng tur a ni.
- ii) Mizoram Sawrkar, Disaster Management & Rehabilitation Department order No.B.13021/101/2020-DMR/Vol-IV dated 29.05.2021 **Clause B.4** hnuiai Sawrkar office chungchange inkaihruaina tarlante chu Khawzawl District Headquarters-ah pawh hman tur a ni.

4. District Headquarters chhunga hmasawnna hna thawh chungchang:

- i) **Mahni in/compound chhungah mi panga (5) aia tam lovin hna thawh phal a ni.**
- ii) District Headquarters a khawsa/cheng ten hmasawnna hnathawh hrang hrang, quarry-a lung lak, kawng laih leh maintain, lei dawh, tui lak, adt. khaw pawnna hnathawhna hmun an pan leh riahchilha hnathawh phal a ni. - iv) Khawzawl Town area chhunga cheng/ khawsa, lo leh huan neitute, ran vulhtute, sangha dil neitu te leh a thawktute chu phalna hranpa lak ngai lovin an hna thawh phalsak an ni a, lo/ huana hna thawk tura ram riah pawh phal a ni. Hmun khata mi 5 (panga) aia tam awmkhawm erawh chu khap a ni.
- v) Lo/ huana kal/ feh turte chuan **zing dar 9:00** hmain khaw chhung (city/town area) an chhuahsan hman tur a ni. Tin, VLTF lehkha emaw, an kalna tur lo/huan an nei ngei a ni tih lantirna document (LSC, periodic patta, adt.) an keng ngei tur a ni.
- vi) Mahni ina thil siamna (home based industry) – Carpentry workshop, steel fabrication workshop, bakery, puan thuina, puan tahnna leh hetiang lam thil thawhna hmunahte chuan a awmchilhtu, hnathawktute tan VLTF hriatpuinain hnathawh phal a ni a. Amaherawhchu, pawnlam mi chhawr phal a ni lo.
- vii) **District Headquarters chhunga phalna neia hnathawkte bungraw/hmanraw phurh leh slab chhun chungchangah chuan he order Clause A.7 a inkaihhruaina hi hman tur a ni.**

- iii) Postal service, blood donation camp/service.
- iv) Kohhran hna ṭul zual thawk tura Kohhran office kal leh kohhran hotute programme pawimawh bik.
- v) Nau pai, nausen pawmlai leh naupang te hnena nutrition (chaw ṭha) sem bakah nutrition sem tur godown aṭanga phurh chhuah leh sem darh.
- vi) Bawngnute sem leh lakkhawm.
- vii) Power & electricity, Public Works Department, water supply (mimal tui chawite huamin), sanitation & solid waste management (hmunphiat leh bawlhhlawh pahi te huamin), telecommunication, internet service, broadcasting leh cable service, septic tank service (ek pahi).
- viii) Print & electronic media leh chanchinbu sem.
- ix) Bungraw load leh unload hna (8:00 PM leh 4:00 AM inkarah).
- x) Private security service.
- xi) Medical emergency leh chhiat tawh thila awmna veng VLTF te hriatpuina lehkha nena chhuah.
- xii) LPG delivery service.
- xiii) Courier service, e-commerce leh home delivery. Heng hian State pawn leh State chhunga dawrkaite bungrua online emaw phone hmanga

kaihhnawih hna ṭul thawk tura an inhawn a huam a ni. Tin, CAB ṭha taka zawm chungin bungrua deliver-tute chuan inchhungah lut lovin an thil sem te chu an pe tur a ni.


