In pursuance of notification No. D. 12016/21/2019-AH&V of 22nd October, 2019, permission is being given for import of healthy adult pigs known to be free from PRRS, African Swine Fever, Classical Swine Fever, etc., to private dealers who have Soundness Certificate from Registered Veterinary Practitioners, AH&Vety. Department and Director, Commerce & Industries Department, Government of Mizoram. Those pigs imported under valid licence and carried about within Mizoram will not come under the effect of Prohibition Orders issued by District Magistrates under Cr. PC 144. In order to facilitate procurement of adult pigs/pork before and during Christmas/New Year celebrations, pigs imported under valid permits and soundness certificates are allowed to be transported between the districts also.
