#### **5. Zin veivah chungchang:**

- iv) Home Quarantine/CQF/GQF a awmte hi sawrkar dan dinglai angin an inkhunghran hun a tawpah test an ni ang a, negative result an neih chuan inkhunghran chhunzawm a ngai tawh lo ang. Positive result neite chu sawrkar dan dinglai angin DCHC/Covid Care Centre/Community Covid Care Centre/Home Isolation ah enkawl an ni ang.
- v) Mizoram pawn atanga lo lut, quarantine exempt theihte chu H&FW Department-in inkaihhruaina an siam anga kalpui tur a ni.
- vi) Mizoram Sawrkar, Disaster Management& Rehabilitation Department dan dinglai angin Lengpui Airport atanga zinchhuak leh lo lutte chuan Transport Departmentin empanelled vehicle, Order No.G.28016/2/2020-TRP dt.16.04.2021-a a tarlan te leh anmahni lirthei an hmang thei ang. Kalkawngah midang nena in-contact tura din khawmuang loh tur a ni. Tin, motor hmanga Mizoram lo lut te chuan an motor hmanlai hmangin an kalna tur hmun an pan nghal tur a ni. Amaherawhchu, remchan lohna avanga motor thlak a ngai a nih chuan mahni private motor uluk taka tithianghlim/sanitize-in emaw Transport Department empanelled motor hmangin an kal chhunzawm tur a ni.
