District Supply Chain Management Committee (DSCMC), Khawzawl District ni 14.4.2020 thukhawm leh Sub-Committee on Enhancement of Food Production for Khawzawl District in a rel angin, Khawzawl District chhunga khaw awm zawng zawngte COVID-19 hrileng avanga kan nitin mamawh-ei leh bar /chawhmeh ah tun mai nilo nakin zelah harsatna kan tawh theih avangin, lo inhmakhua a mitin intodelh tura hma lak a tul hle in a hria a. Chuvang chuan Khawzawl District mipui te hriat atan leh zawm turte a hnuai ami ang hian ka rawn tarlang e:-

1. Kuminga Khawzawl District a loneitu/thlawhhma nei zawng zawngte mahni thlawhhma chhungah changkham tihvek ni thei se, hei hian leichung hang tha luang ral mai tur a ven bakah thlai hrisel leh tam zawk a thar theih phah dawn a ni.
2. Lo/thlawhhma nei lo te pawh mahni khua/veng a V.C te phalna in chul rit tura hmalak nise, theihtawp chhuah theuh turin loneitu zawng zawngte kan innge a ni.
3. Lo/thlawhhma nei lo te pawhin mahni in bulah chuktuah huan siam theuh turin kan innge in kan inhriattir a. Chuktuah huan siam remchan lohna hmunah pawh inchung zawl ah sangha bawm/bucket chhia emaw polypot hmanga thlai ching uar tura hma la theuh turin kan innge e.
4. Tun maiah chuan ram danga hralh chhuah ngai chi (Commercial Crops)- Sawhthing leh Aieng chu ching uar rihlo turin kan innge a. Buhbal chi hrang hrang buh te, vaimim ching uar zawk turin thurawn kan inpe e.
5. WRC a buhchingtute pawh a thar hlawk theih dan- SRI (System of Rice Intensification) method emaw line planting emaw hmangin buh ching uar turin kan in chah a, SRI anga buh ching turte hriat atana pawimawh te:-
 - a) Buh chi kui hi ni 12-15 inkar a upa tur a ni.
 - b) Buh phun inkar hlat zawng hi 25x25cm tur a ni.
 - c) Buh phunsawn anih atangin ni 30 hmaiin thlawh fai ngei tur a ni.
 - d) Ni 40 na thleng tui tlin tir loh tur.
6. Thlai chin hun dik a hnuai mi ang hian zawm ngei nise:
 - a) **March-May:** Bawkbawn, Samtawk, Changkha, Berul, Behlawi, Hmarcha, Antam, Mai, Bawrhsaiae, Maipawl, Fanghma, Bean, Dhania, Vaimim, Bekang chite thlak hun. Fur zikhlem (Ryozeiki) chin hun a ni bawk
 - b) **June:** Tomato variety Arka Rakshak leh Arka Samrat. Tui neitha tan kumtluanin a chin theih.
 - c) **August-October:** Thlasik thlai Zikhlem, Parbawr, Brocolli, Bean, Purun Sen, Purun Var, Carrot, Bul Uih, Chanate chin hun lai a ni. Hmun thenkhatah chuan Alu pawh a chin theih bawk e. August thla hma lam hi Badam chin hun tha a ni e.

7. Agriculture dawr Farmer's Plaza, Khawzawl a mi chu mipui a mamawh te tan dawr theih reng an ni a. Tin, mimal thlai chi zuarte pawh Chhipchhuan Bazar hnuai, Vengthar Khawzawl ah zing dar 9AM-4PM thleng dawr theih an ni bawk.
8. Khawzawl District chhunga khaw tinte thlai chi chin sen bak nei in awm chuan VCP tin ten tlawnngaia lo lakkhawm in, Zonal Officers- Covid-19 kaltlang in emaw, a remchan danin DC, Office Khawzawl ah rawn dah turin kan innge a. Thlai chi lakkhawm theih ang ang te chu a mamawhte hnenhah semchhuah leh a ni anga, DC Office atang hian Agriculture Office leh KVK, Khawzawl ah '**Seed Bank**' siamah vawn that a ni ang.

Mahni intodelh turin hma la theuh ila, Khawzawl District leh midangte tan malsawmna nih theuh i tum ang u.
