

**MINUTES OF MEETING OF LOCAL PURCHASE ADVISORY BOARD HELD IN  
THE OFFICE CHAMBER OF ADDL. DEPUTY COMMISSIONER, KHAWZAWL  
DISTRICT ON 21.06.2021**

The meeting was chaired by Pu Lalrohlua, Additional Deputy Commissioner, Khawzawl District and the following officers were present:

The meeting of the Board was convened to discuss and recommend the procurement of equipments required for technical support and capacity building of District Emergency Operation Centre (DEOC), Khawzawl District to enable a better coordinated disaster response, as part of National Disaster Management Authority, Government of India project on "Capacity Building of Emergency Operation Centre".

The Board undertook a survey of the local market with a view to ascertain the reasonableness of rate, quality and specifications for procurement of equipments for DEOC, Khawzawl District. A comparative statement on each of the items along with quoted rates was placed before the Board as follows: -

After detailed deliberation, the Board recommended that the firms with the lowest prices be selected for procurement of the above-mentioned items from the funds made available for the project under State Disaster Response Fund vide Government of Mizoram, Disaster Management & Rehabilitation Department Order No.B.13015/9/2019-DTE(DMR) dated 24.03.2021

The meeting noted that the L1 amount of Rs. 79,100/- only for Portable Diesel/Petrol/K-Oil Generator Set is more than the amount sanctioned i.e., Rs. 57,000/- only in abovementioned Govt. of Mizoram, DM&R order. This is because Portable Diesel/Petrol/K-Oil Generator Set with desired specification of "at least 2KVA Petrol Generator set" is not available in local market within the sanctioned amount. The difference in prices is to be met from savings (Rs. 22,100/- only) obtained from purchase of Smart LED TV - 55" (with requisite specifications and quality) for the same project.




