1. Mizoram pawn atanga Khawzawl District-a lo lut/haw turte chuan an rawn haw hma ngeiin anmahni bialtu VLTF emaw, Zonal Officer emaw hnenah in report tur a ni.
2. India ram hmun dang atanga lo lut, Point of entry a Rapid Antigen Test (RAgT) hmanga endik negative te chu Khawzawl District chhung an lo thlen hnuah midang nena in-contact lo leh fimkhur taka mahni hriselna inchik reng chung in ni 7 chhung inkhunghan tur a ni. Amaherawhchu, Mizoram an thlen hnua RT-PCR/TrueNat test an neih a, negative result an neih chuan inkhung zui a ngai lo ang.
3. India ram pawn atanga lo lut leh COVID-19 UK, Brazil adt. variant/strain lenna ram atanga Khawzawl District a lo lut/haw te chu Health & Family Welfare Department inkaihhraina siam angin quarantine ngei tur an ni. Amaherawhchu Mizoram an lo thlen hma a India ram chhungah ni 10 aia tlem lo awm an nih in leh point of entry-a RAgT negative result an neih erawh chuan ni 7 chhung an mahni inah an inkhunghan ang.
4. Hun rei lote chhung (short stay), darkar 96 aia rei lo Mizoram a cham tura lo kal te chuan Mizoram an lo thlen hma darkar 96 aia hlui lo RT-PCR/TrueNat/CBNAT (ICMR recognized laboratory) hmanga COVID-19 test result negative (SRF ID awm) an neih a, Mizoram entry point-ah RAgT negative result an neih bawh chuan inkhung hran a ngai lo ang. Anmahni chah chhuaktu ten an tana hmun ruat bikah dahin, midang nena in contact lo thei tur ang berin ruahmanna an siam ang.
5. State pawn atanga Khawzawl District a lo haw, inkhung hran tur phurtute chuan an passenger-te nena in-contact lo thei tur ang berin fimkhur takin ruahmanna an siam ang a. Kalkawngah pawh midang nen an in-contact tur a ni lo.

6. Mizoram pawn atanga Khawzawl District a lo lut/haw turte chuan Mizoram an rawn luh hmains **mCOVID-19 mobile application mPASS-flight emaw mPASS-road** hmangin an in-register lawk tur a ni. Home quarantine dil duh tan online in <https://mcovid19.mizoram.gov.in> ah a dil theih bawk. Online hmanga Home Quarantine dil remchang lo te tan mahni thlenna tur VLTF/bialtu Zonal Officer te hnenah in report tur a ni.
7. COVID-19 positive ni lo emaw Containment Zone/Area atanga lo kal ni lo, Mizoram chhung District dang emaw khaw dang atanga lokal an nih vang ngawtin mi tumah lo quarantine tur a ni lo.
