Hei hian khawvel huapin ei leh bar zawn kawngah harsatna namen lo a thlen a, mitin sum leh pai dinhmun a nghawng a ni.

Hetiang dinhmun khirh taka kan din tak avang hian hripui Coronavirus (COVID-19) avanga inkharkhipna (Lockdown) kalpui tan tirh atang khan Khawzawl District-a Mipui ten Ei leh bara harsatna kan tawh loh nan kawng hrang hranga hmalak a ni a. Chung zingah chuan thil man tisang lo tura ngenna leh khapna thupek hial te pawh tihchhuah a lo ni tawh a. Heti chung hian mi thenkhat chuan Sawrkar thuneitute Ngenna leh Thupek an ngai pawimawhlo ni a hriat a ni a, a bik takin Sa zuartu/ Sa sattu thenkhat ten he hun harsa tak hi remchanga la-in Sa rate an ti sang tih hriat a ni. Hei vang hian June ni 11, 2020 khan District Bawrhsap, Superintendent of Police, Sub-Divisional Magistrate, Officer-in-Charge, Khawzawl Police Station, Khawzawl Town VCP-te leh Sa sattu/Sa zuartute chu DC's Conference Hall-ah thukhawmin Sa rate chungchang leh a kaihnaawih thil chi hrang hrang sawiho a ni a. Hripui leng kara mipui ten kan taksa mamawh eitur tha rual khai taka kan hmuh theihna turin thu leh awm hma atan, ahnuai a mi ang hian Khawzawl District tan Sa rate (upper ceiling) bithliah a ni a, lungrual taka pawmtlan a ni.
