Tunhnaiah Mizoram chhungah Covid-19 vei, khawi atanga kai nge tih leh kai chhan hriatchian loh an pun chhoh zel avangin community spread (khawtlanga inkaidarh) a awm tan tawha ngaih a ni a. He community spread dan chah a nih theih nana Mizoram sawrkar thupek (Order No. B. 13021/101/2020-DMR/VoI-II/Pt\_II dt. 23.10.2020) angin Khawzawl District-chhungah October 26, 2020 atanga November 9, 2020 thleng **Covid-19 No Tolerance Fortnight** hman tur a ni. Hemi hun chhunga inkaihhraina chu a hnuaia mi ang hi a ni ang:

1. Khawzawl District chu Zone 13 ah then niin, Zone tinah Sawrkar hnathawk, police leh VLTF te awmna **Covid-19 Executive Duty Team** din a ni. Team member leh an hmalak dan tur kimchang chu Zone tin-a Team Leader-te hnenah hemi lehkha number dt. 24.10.2020 kaltlanga hriattir a ni.
2. No Tolerance Fortnight chhung hian The Mizoram (Containment and Prevention of the spread of Covid-19) Act, 2020 leh Covid-19 kaihhnawiha thupek hrang hrang bawhchhiate chu dan hmanga hrem theitute kaltlangin inngaihnhnathiamna awm lovin hmun leh hmunah pawisa chawitir/hrem zel an ni ang.
3. Mizoram sawrkarin September 30, 2020-a Unlock 4.0 Order a tihchhuah chu khuahkhirhna thenkhat a siamrem telin hman chhunzawm tur a ni. Khuahkhirhna tihdanglam thenkhatte chu:
  - i) Head of Office-ten thawktu 70% chu a inchhawkin office an kaltir ang. A bak 30%, Head of Office in Deputy Commissioner hnena an rawn thehluhte chu 'Covid-19 Executive Duty' atan hman an ni ang.
  - ii) School, college leh educational/coaching institute te chuan online hmang chauhin zirtirna an kalpui tur a ni. Zirtirtute rawn tura school kal pawh khap a ni.
  - iii) Games & Sports tournament huaihawt khap a ni a, games & sports practice-na hmun – indoor-ah mi 10 leh outdoor-ah mi 25 aia tam awmkhawm phal a ni lo.
  - iv) Cinema hall, auditorium, community hall, swimming pool, picnic spot leh Gym te chu khar chhunzawm tur a ni.
  - v) Mitthi vuina leh inneihna (man hlan/inneih inkhawm leh reception) ah te chuan mi 35 (sawmthum panga) chin punkhawm phal a ni. Lungphun, anniversary, pawl thila kalkhawmna, book release adt. ah te chuan mi 20 (sawmhnih) aia tam punkhawm

khap a ni. Heng hmuna tel te chhinchhiahna kimchang (hming, address, phone number leh kal hun te) ziahna bu register chu a huaihawttu ten an vawng tur a ni.

4. Kan lo him tlan zawk theih nan Khawzawl Darngawn Veng-a Mualvawm Park leh a chhehvel chu tlai dar 5 atanga zing dar 4:30 inkar chhung tlawh khap a ni.


