I. Mipui vantlang tana inkhuahkhirhna hriat turte:

1. Phalna nei lovin tumahin mahni in/compound an chhuahsan tur a ni lo.
2. A chungah order tarlanin Clause A.5, B.2, B.5 (2, 3 & 11) leh B.6 hnuaiia a phalsakte bak lirthei hmanga veivah khap tlat a ni.
3. Pawn chhuak tur reng reng chuan face mask leh hmanraw dang hmangin hmai an tuam ngei ngei tur a ni.
4. Vantlang hmuna kal te chu feet 6 tala inhlata awm tur a ni.
5. Village Level Task Force (VLTF) ten an huamchhunga dawr hawn an remtihsak te bak chu dawr hawn phal a ni lo. Phalna neia dawr hawnte pawh tlai dar 5:00 ah khar vek tur a ni.
