**Subj: Law & order Situation during Lockdown in Khawzawl District.**

In pursuance of Office Memorandum issued by the General Administration Department, Government of Mizoram vide No. B.14015/50/202f0-GAD dt. 21.3.2020 and MHA letter No.40-3/2020-DM-I (A) dt. 24.03.2020, and to augment the compliance of the lockdown for prevention and mitigation of Coronavirus (COVID-19) under Khawzawl District, Prohibitory Order U/S 144 Cr.Pc, 1973 (Act II OF 1973) dated 4.04.2020 was issued by the District Magistrate with the mandate of restricting the gathering of more than 5 people, entry of vehicles to Khawzawl District without passes issued by concerned authorities, promulgation of false information to the public regarding Covid-19 etc. On the basis of the Prohibitory order the District Administration in close coordination with the Police forces has taken stringent action to book any culprit whose act misalign with the mandates of the Prohibitory Order. 5 (Five) violators of the Prohibitory Order were booked under Khawzawl Police Station case No 7/2020 dated 5.4.2020 U/S 188 IPC R/W 51 (B) of Disaster Management Act, and were sent to Judicial Custody of District Court, Champhai. However, the 5 (Five) violators were released by the District Court, Champhai on Personal Recognizance (PR) bond on 6.4.2020.

Movement of vehicular traffic are put to a grinding hold except for exempted categories. All shops/market of essential commodities are completely closed. Village Level Task Forces (VLTF) effectively performed their duty in their respective Jurisdiction along with the police forces. Mobile patrolling via. Prison van etc. is carried out by the Police, and Drone is also deployed for better surveillance during lockdown. There is a recovery of 20 bags of Betel Nut from a truck bearing Regn. NO. MZO1-N/5467 coming from Champhai which is seized and is handed over to the Custom Department, Champhai.


Beside the above stray case, the overall Law & Order situation is peaceful, and the general population are well grounded at their Homes, being fully aware that staying Home is the panacea in the fight against the Novel Coronavirus (COVID-19).
