

MEETING MINUTES IN CONNECTION WITH MAINTENANCE OF LAW AND ORDER DURING CHRISTMAS AND NEW YEAR FESTIVALS

Chairman : Pu H. Lianzela, Deputy Commissioner, Khawzawl.
Venue : DC's Conference Hall
Date & Time : 20th November, 2019 (Wednesday), 11:30 AM

At the outset, the Chairman welcomed all the members and requested them to have a round of self-introduction. This was followed by introductory remarks on the changing scenario of maintenance of law and order in the context of Khawzawl Town being the Administrative headquarters of Khawzawl District by the Chairman. After deliberation and fruitful discussion, the meeting appropriately resolved the following points :

1. **MAINTENANCE OF LAW AND ORDER DURING CHRISTMAS-2019 AND NEW YEAR-2020** : Taking into consideration the report of Superintendent of Police on the measures taken regarding maintenance of law and order during Christmas and New Year Celebration, 2018 in Khawzawl Town, the following arrangements are made for maintenance of law and order during Christmas-2019 and New Year- 2020 Festivals :-

- 1) Information Center/Duty post shall be put in place in each Village Council Area with the initiative of VC, YMA and other NGOs within Khawzawl Town. The additional Information Center/Duty post in a Village Council area shall be decided by the concerned VC, YMA and NGOs as per their requirements.

Action: All VC, YMA

- 2) Information Center/Duty post shall be made operative from 22nd December, 2019 till 2nd January, 2020. Magistrate and Police on Duty are also expected to visit the Information Center/Duty post in each Village Council Area during the period.

Action: DC, SP, VC & YMA

- 3) Three Police Duty Posts shall be put in place within the Town Area at a suitable location to be identified by the Police. Apart from static duty at various strategic locations, Mobile Patrolling by Police shall be carried out at frequent intervals.

Action: SP, Khawzawl

- 4) Extra vigilance and special security arrangement shall be made at Mualvawm Field, Helipad, DC's office during 22nd December, 2019 to 2nd January, 2020. No person shall be allowed to stay, enter or engage in any activity of any kind which can cause public

Disruption in and around the said premises after 8:00 PM during 22nd December, 2019 to 2nd January, 2020. In addition to District Executive Forces, all Branch YMA may detail their members to assist police personnel at Mualvawm Field on 2nd January, 2020.

Action: SP, VC & YMA

5) On the particular days such as- 26th December, 2019 and 2nd January, 2020, all concerned in the maintenance of Law and Order are expected to be more active, vigilant and more responsive to any eventuality which may occur within the Khawzawl Town in particular and the Villages of Khawzawl District in general.

2. **PROHIBITORY ORDER** : Import, Sale, Use and Storage of any explosive devices, Firecrackers and any other form of fireworks, and also any form of Gun Toys which may cause physical harm to any person shall be prohibited during Christmas and New Year Festival, 2019 by issuing Order under section 144 CrPc..

Action: DC

3. **ROAD SAFETY-CHECKING OF PUBLIC TRANSPORT, LIQUOR & DRUGS/ MOBILE COURT**: Checking of Public Transport and Mobile Court shall be carried out and intensified by Police (DEF) so as to ensure safety of the public and passengers travelling in public transport during Festive season.

Action: VC, YMA, All NGOs

4. **MOTOR GARAGE**: Road Protection Squad is entrusted to conduct on the spot study and give a feasibility/comprehensive report on enforcement of compulsory provision of Motor Garage within Khawzawl Town. They are expected to submit a report by 16th December, 2019.

Action: SDO (S) & SDC

5. **MOTOR PARKING NEAR SBI OFFICE** : SP Khawzawl shall make necessary arrangement for hassle-free vehicle parking near SBI office, junction and adjacent area at Vengthar, Khawzawl.

Action: SP


6. **PERMISSION FOR CONSTRUCTION OF BUILDING**: Any person, who is planning to construct/erect a house, building or any structure on the roadside, highway, public road- may it be internal road, where the road is utilized by the public, shall obtain prior permission from the DC/District Magistrate, Khawzawl through Village Council.

Action: DC

7. **CONTROL OF ANIMALS** : Prohibitory order for control of Animals in Khawzawl Town shall be issued by the District Magistrate under section 144 of CrPc.

Action: DC
