Subject: Adherence to Covid-19 Appropriate Behaviour - Regarding

Sir,

With reference to the subject cited above, and in view of the continual detection of Covid-19 positive cases among persons accommodated in your camp at Zaupui (Dulte), with random test conducted by Kawlkulh PHC officials on 01.06.2021 affirming local transmission of the Covid-19 virus in the camp, you are hereby directed to strictly adhere to Covid-19 Appropriate Behaviour (CAB) and other extant Government Orders in connection with Containment and prevention of the spread of Covid-19.

- 1. Work and other activities in the camp shall be carried out/executed without mingling with residents of Dulte and other nearby villages.
- 2. Any movement of persons to and from the camp shall be intimated to, and prior approval obtained from concerned Zonal Officers/District Administration.
- 3. All persons coming to Anusha Projects Pvt. Limited (APPL) from outside the State shall mandatorily undergo a **10-day quarantine** in designated Quarantine Facilities arranged by APPL, after which they will be tested for Covid-19 using TrueNat. Only those who tested negative may leave quarantine facility. (Provided they did not come into contact with Covid-19 positive persons during the quarantine period).
- 4. All primary contacts of Covid-19 positive persons must undergo **quarantine for minimum 7 10 days** in designated Quarantine Facilities arranged by APPL, after which they will be tested for Covid-19 using TrueNat. Only those who tested negative may leave quarantine facility.
- 5. All secondary contacts of Covid-19 positive persons must also undergo quarantine until results of primary contacts are known. If primary contact's result is Covid-19 positive, swab sample of secondary contact persons shall also be tested for Covid-19.

6. Arrangements must be made to provide food at separate locations for quarantined persons.

- 7. Persons discharged from Covid Care Centres must also undergo quarantine for 7 days in designated quarantine facility.
- 8. Failure to strictly observe the standard guidelines/instructions in connection with the containment of Covid-19 entails penalty under relevant provisions of the Mizoram (Containment and Prevention of the spread of Covid-19) Act, 2020.
