REPORT ON INSPECTION OF ROADS IN KHAWZAWL ON 14.10.2020

To ensure compliance of prohibitory orders issued by District Magistrate, Khawzawl vide order number J.12017/1/2019-DC(KZL) dated 29th September, 2020, inspection of public roads was conducted on the morning of 14th October, 2020. The inspection was headed by Pu Zothanmawia, Deputy Commissioner, Khawzawl and assisted by Road Protection Squad, Khawzawl along with Village Councils and Young Mizo Associations of concerned localities.

The inspection started at 6:30 am from DC's Bungalow, Darngawn. It was carried out on foot and covered Darngawn, Zaingen, Zuchhip, Dinthar and Vengthar localities along the main road.

The following members of Road Protection Squad were present:

1. Convener – Sub-Divisional Officer (Sadar)
2. Member Secretary – Sub-Deputy Commissioner
3. Members – Sub-Divisional Police Officer
 - Sub-Divisional Officer, PWD
 - Chairman, Joint VC as well as VCPs of the localities in which inspection was carried out.

Other members including SDO (PHE), SDO (P&E) and President, Jt. YMA were absent without prior intimation.

It is to be noted that inspection of roads is an important responsibility that is to be taken seriously by every member of Road Protection Squad. It is an essential activity to safeguard existing roads and to prevent encroachment and activities causing damage to public roads. Therefore, future absence without prior intimation will be treated as negligence of duty and should be avoided.

During the inspection, several cases of encroachments into public road reserve areas and actions causing obstruction/nuisance to public roads were found. The offenders were notified on the spot to remove such encroachments/nuisances within time limits specified based on the kinds of transgressions, to which they agreed to comply. They are also issued written notices through their respective Village Council Presidents.
