

**MINUTES OF THE MEETING OF OFFICERS IN CONNECTION WITH  
ILLEGAL TRANSPORTATION OF ARECANUT, PROHIBITION OF IMPORT OF  
PIG, RATE OF PORK, Etc.**

**Venue** : **DC's Conference Hall, Khawzawl**  
**Date & Time** : **19<sup>th</sup> August, 2020 @ 12:00 Noon**

Pu Zothanmawia, Deputy Commissioner, Khawzawl chaired the Meeting. Welcoming the members, he apprised them that there has been report of illegal transportation of Arecanut through Khawzawl District which seems to have come from Myanmar and the meeting has to decide what measures has to be taken to curb this illegal act.

Pu PC.Lalchunglura, Superintendent of Police, Khawzawl District reported that Khawzawl Police is aware that Arecanut are being transported from Champhai through trucks and these trucks used to pass through Khawzawl Town **via Ngaizawl**. But they are not aware of the fact that these trucks also passes through Khawzawl Town **via Neihdawn**. As per the report received today, Addl. SP, Khawzawl has been sent to Neihdawn to see the situation on the spot.

The Meeting is informed that DC, Khawzawl has issued Prohibitory Order which forbid Truck carrying goods to pass through **Ngaizawl** on 6<sup>th</sup> August, 2020. As such, SP, Khawzawl has recently seized one truck which is awaiting transportation of Arecanut to be carried towards Aizawl. Since there is report that Trucks are now passing through **Neihdawn**, the Meeting made the following decisions after thorough deliberations:-

- A. 1. Prohibitory Order:** DC, Khawzawl will issue Prohibitory Order today i.e. 19.08.2020 to forbid movement of vehicles carrying goods **via Neihdawn**. A copy of this order will be given to DC and SP, Champhai as well as Sub-Hqrs., YMA, Champhai.
- 2. Check Gate:** A check gate will be made at Chaltheikawn. Jt. YMA, Forest Department, Police and VLTF will be detailed for duty. Since, there is shortage of Police Staff due to the ensuing VC Election, this Check Post will function after General Election is over. Meanwhile, checking of vehicles will be conducted by Police at Kawnzar Check Post with immediate effect. The SP of Khawzawl is expected to do the needful to make Check Post at Chaltheikawn to function during this month. Efforts should be made to register all trucks carrying goods. Moreover, the Meeting decided that Forest Department will continue to operate their check post at Chhumliamkawn. They should concentrate on illegal transport of local trade.

- B. 1. Import of Pig:** The Veterinary Officer, Khawzawl reported that there is no report of import of pig from Myanmar and other States. DC, Khawzawl had issued Prohibitory Order in this regard which will be re-issued today. The Meeting is informed that due to the wave of COVID-19, there is no Intra-District and Inter-District transportation of pig.
- 2. Rate of Pork:** There has been rumour that rate of pork is irregular in Khawzawl Town. The Meeting decided that consultation with VCs and Butcher Association will be convened after VC Election is over in order to find ways to regularize the rate of Pork within Town.
- 3. Intimation to Veterinary Officer:** The meeting also decided that any Butcher who intends to slaughter pig should inform the VO, Khawzawl who will in turn conduct Anti-mortem examination with the Community Health Worker.

The meeting ended with vote of thanks from the Chairman.
